




Construction 2023













More than 500 active establishments in the Construction sector in 2023

The Construction sector has 509 active establishments in Monaco in 2023, more than 80% of which are in Specialised construction activities (413 entities) involved in just one part of the building process such as structural works or finishing works (including electrical or plumbing installation). The remaining 20% are dedicated to the construction of entire structures (Construction of buildings and Civil engineering).

Construction businesses are mainly Limited liability companies, accounting for 52.3% of the total, compared with 30.0% in Monaco overall.

The number of establishments in this major economic sector (MES) is the same as in the previous year, after 14 business creations (all of them in the Specialised construction activities) and 14 permanent strike-offs.





In 2023, Construction revenue exceeds €2.8 billion, up by more than €300 million compared with 2022 (+12.0%). With a share of 13.8%, this sector remains the third-

While Construction revenue has more than doubled in ten years, rising from €1.2 billion in 2014 to €2.8 billion in 2023, turnover across all sectors in Monaco (excluding Financial and insurance activities) has increased by a factor of 1.6.

Reflecting the number of active companies in the sector, the majority of Construction revenue is generated by Specialised construction activities, which account for almost two-thirds (65.4%, or €1.8 billion). While the result for this NAF division corresponds to an increase of 6.9% compared with 2022, the biggest change concerns Construction of buildings, which posts an increase of 28.6% in 2023. Civil engineering turnover, which accounts for 3.1% of the MES, fell by 12.6% over the period. Within Specialised construction activities, Masonry works and building structural works remained at a high level, with revenues of around one billion euros.

With 6,645 employees at the end of 2023 excluding temporary staff, the Construction remains the third-largest provider of jobs in the Principality. It has 512 more workers than the previous year, i.e. a more dynamic 8.4% rise than the private-sector employment as a whole (5.1%).

Three quarters of the MES's workforce (74.8%) are in Specialised construction activities whereas the Construction of buildings represents 22.6% of the total. The remaining less than 3% correspond to Civil engineering employees.

There are 364 employers in the Construction sector at the end of 2023 (+4 entities over a year), still accounting for 5.7% of all employers in the Principality.


The sector with the highest proportion of men and Italian residents among its employees

6,115 men and 530 women make up the permanent workforce in Construction in 2023, which remains the most maledominated MES at 92.0%. The majority of employees in this sector are aged between 35 and 54, and the average age is slightly higher than for the private sector as a whole (43 compared with 42.4).

While employees of French nationality remain the most numerous in Construction, they represent just under half of the MES workforce in 2023 (49.4%). They are followed by Italians and Portuguese, present in the same proportions (about 18.5% of the staff). Around twenty Monegasques are employed in the Construction sector.


Less than 4% of workers in this sector are Monaco residents in 2023, which is the lowest proportion observed among the MESs. Furthermore, the Construction sector has the highest proportion of employees living in Italy, at 15.5%. It also has the second highest number of Italian residents in value terms (1,019 employees) behind Scientific and technical activities, administrative and support service activities.

Construction companies rely more heavily on temporary work than any other sector. Almost two-thirds (65.6%) of the total number of days worked by temporary staff in 2023 were in this sector, mainly in Specialised construction activities. Construction generated almost half of the year's assignments (48.1%), employing around 8,000 temporary workers between January and December 2023 (57.0% of the workforce).

The Construction sector includes general and specialised construction activities for buildings and civil engineering projects (new construction projects, renovations, repairs, extensions and transformations, and construction of prefabricated buildings). It also includes the development of building projects, where such activities bring together the financial, technical and human resources required to complete real estate projects that are ultimately destined for sale (see NAF version 2, 2008).
